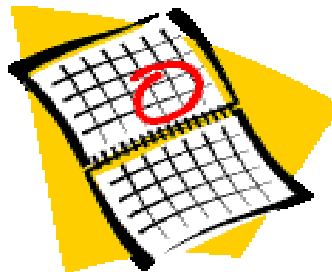

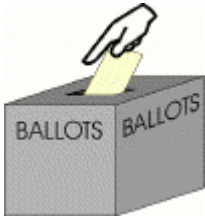

Meet the Candidates

So you can get to know the candidates a little better, they have submitted the following:

Larry P. Totten

Larry Totten graduated from the Kentucky CPM Program in 1993 and immediately joined the Kentucky Society and American Academy of Certified Public Managers. Since then, he has been an involved and active member, serving on many state and national committees and being elected to state and national offices.

Larry served as President-Elect, then President of the Kentucky Society of Certified Public Managers in 1996 and 1997. During this time, was a member of the Host Committee as Kentucky hosted the AACPM Professional Development Conference in 1996. The Society's Annual Conference was held for the first time in 1997.

He was elected Academy Treasurer in 1998, re-elected in 1999, and appointed Board Member-at-Large in 2001. He was elected President-Elect of the Academy for 2002, assumed the Presidency in 2003, and is finishing 2004 as the Immediate Past President. In 2004, he won the Henning Award, presented by the AACPM to an outstanding member who has made the greatest contribution to the certified public management program at the state and/or national level.

Following re-accreditation of Kentucky's CPM program in 1999, Larry was asked to become a charter

member of the Advisory Board and worked within that group, including time as Chair. He participated in the 1999 accreditation review for the Ohio CPM program and the 2003 re-accreditation review of the Wisconsin CPM program.

Larry is a 29-year veteran of Kentucky state government whose "day job" today is that of Park Manager at Lake Cumberland State Resort Park in Jamestown. Within this role, he has also earned a second professional certification, that of Certified Hotel Administrator, an internationally recognized designation within the lodging industry.

Carmen Bishop

Carmen is currently the Compliance Branch Manager for the Division of Securities for the Office of Financial Institutions.

She joined the Office of Financial Institutions in December 1986 and held the position of Bank Examiner for 11 years, conducting bank and trust examinations. She obtained the designation of Certified Examiner in 1993.

In October 1997, Carmen transferred to the Division of Securities to help establish a securities examination program. She currently supervises four securities examiners, and conducts investment adviser, broker-dealer, and issuer agent examinations. In addition to her securities examination duties, she currently serves on two North American Securities Administrators Association (NASAA) committees: Investment Advisor Training Committee and Standards,

Certification and Training Committee. Carmen also teaches at investment advisor trainings conducted by NASAA.

Prior to joining the Office of Financial Institutions, she was in commercial sales for four years. Carmen graduated from the University of Kentucky with a bachelor's degree in Communications in 1982, and received a Masters Degree in Business Administration from Xavier University in 1984.

Carmen completed the Certified Public Manager's program in November 2003 and served as the KSCPM Secretary from May to December 2004.

Robinil Jameson

Being a career state employee, I have experienced first-hand the need for perpetual development of managerial candidates to secure the integrity of policy implementation and program oversight.
