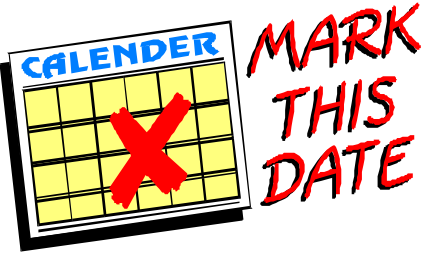

The Board meeting was called to order by President Ande Godsey on February 8, 2010. The meeting was held in Frankfort, Kentucky.

The following were in attendance: Ande Godsey, Larry Totten, Robinil Jameson, Margaret Puckett, Carmen Bishop, Sheila Gerkin, Katy Cave, Tom Stratton, Lynn Keeling, Cassidy Connell, and Jennifer Woods.

**Presentation of Minutes:** Secretary Tom Stratton presented a copy of the December 8, 2009 Board minutes for review and approval. Katy Cave made a motion to accept the minutes and Robinil Jameson seconded the motion. The motion carried.

**Treasurer's Report:** Treasurer Larry Totten presented the February 8, 2010 Treasurers report. The KSCPM checking account balance is \$9,163.28. Larry stated that a CD recently rolled over. The Treasurer's Report lists three CDs with the following balances: \$2,200.98, \$2,178.72, and \$2,077.92. Robinil Jameson made a motion to accept the Treasurer's Report and Carmen Bishop seconded the motion. The motion carried.

**Committee Reports**

**Membership Committee:** Robinil Jameson requested a motion to give something, such as luggage tags, to members for renewing. Katy Cave suggested green tote bags. Carmen Bishop made a motion to spend no more than \$250

on these renewal gifts. Katy seconded the motion. The motion carried. Robinil Jameson stated that she is working on new brochures.

**Program Committee:** Jennifer Woods stated that the May seminar would be at the History Center in Frankfort. She asked for suggestions for seminar gifts. Katy Cave made a motion that at \$500 cap be placed on the gift spending. Jennifer Woods seconded the motion. The motion carried. Ande Godsey asked for ideas for guest speakers for the May seminar. Suggestions were Julian Carroll, Crit Luallen, and Kentucky Joe. Ande also asked for theme ideas. Suggestions were "motivation" and "attitude." Jennifer Woods asked everyone to email their seminar ideas to her at JenniferL.Woods@ky.gov. Jennifer also asked the committee to consider door prizes.

**Finance Committee:** Carmen Bishop asked for the number of current KSCPM members. Robinil Jameson said that she would email the numbers to Carmen. Carmen will use these numbers to work on the current budget.

**Publications & Publicity Committee:** Robinil Jameson asked the Board members to contribute more articles for the newsletter. She said that she isn't getting very many and she is using more pictures than she wants.

**Legislative Update:** Robinil Jameson stated that there weren't very many bills moving at this time due to a decrease in funds.

**GSC Update:** Katy Cave distributed the Certified Public Manager® Program Annual Report to Board members. Katy stated that there have been 1,204 KCPM graduates since the program's inception. Katy stated the KCPM Program is currently on hiatus and is not accepting new applicants, although those who are currently in the program will finish as scheduled. Three groups will finish this year. The last graduation will likely occur in November 2010.

**New Business:** Ande Godsey stated that there was no new business.

The Board meeting was adjourned.

**Fran L. Wilkinson Scholarship**

Two \$750.00 educational scholarships will be awarded at the 22<sup>nd</sup> Annual AACPM Professional Development Conference to be held in Oklahoma City, Oklahoma on October 17-19, 2010. The scholarship is available to all members of the Academy who are enrolled in a college program that prepares them for a career in public management. Applicants must submit an application form and two letter of recommendation.

The scholarship is named for Fran Wilkinson, an early leader in CPM. Fran was dedicated to professional and adult education. She was president of the Georgia Society in 1983 and chair of the National CPM Consortium in 1987. Fran died unexpectedly on June 6, 1990. On April 30, 1994 the House of Delegates voted unanimously to name the Academy's annual scholarship "The Fran L. Wilkinson Memorial Scholarship" as a token of remembrance, affection, and esteem.

In 2007, KSCPM member Patrick Brown of the Department of Criminal Justice was awarded one of two scholarships awarded yearly by the Academy for continuing education; and in 2008 KSCPM member Rebecca Conley of the Department of Financial Institutions was awarded a scholarship.

The 2010 committee chairperson and application deadline for the 2010 scholarship nominations will be posted on the AACPM website.

The Kentucky Society of Certified Public Managers® (KSCPM) held its annual Professional Seminar at the Kentucky History Center in Frankfort, Kentucky, on May 25. The theme of the seminar was "Successful Leadership with Limited Resources."

The speakers included State Auditor of Public Accounts, Crit Luallen, who said responsibility is the key work in conducting audits and oversight of boards. Ms. Luallen was a speaker at the KSCPM Spring Luncheon in March, 2003 and she continues to focus on ways to improve government management and efficiency.

Jeff Jasper explored the seminar theme with five points to aid managers:

- Words of Affirmation – "thank you", "good job", etc
- Quality Time – setting aside time to meet with employees
- Receiving Gifts – small gesture of appreciation, (having a birthday gathering once a month)
- Acts of Service – assisting others
- Physical Touch – a hand gesture, pat on the back

KSCPM member and GSC instructor, Katy Cave, opened her session by having participants engage in 'behavioral shopping' and interviewing each other to determine 'who are you'?

KSCPM members may be familiar with one of our speakers—Rodger Bingham (Kentucky Joe), who appeared on the hit TV show **Survivor: The Australian Outback**. Rodger currently serves as the Deputy Executive Director of the Office of Agricultural Marketing and Product Promotion for the state of Kentucky. He spoke about farm safety and the importance of helmets when operating four-wheelers. Rodger travels extensively in Kentucky promoting agriculture and speaking to schoolchildren about living a healthy lifestyle.

Each seminar attendee received a tote bag with the KSCPM logo. During the registration period and after lunch, they had time to tour the exhibits at the History Center or visit the various booths in the resource area, before the next session began. People visited with exhibitors that included, the Kentucky Retirement System, Libraries and Archives, and State Parks. Each of these groups were on hand to answer questions and provide information on their programs. The seminar concluded with a drawing for door prizes.

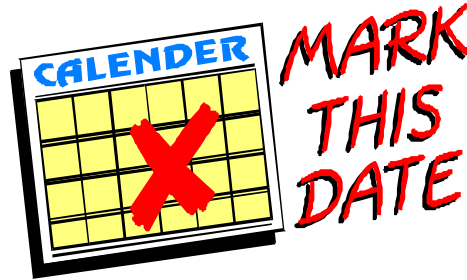

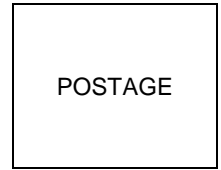
