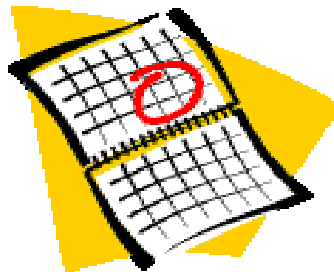

Hoping to see you at the Awards Luncheon, I am respectfully yours,

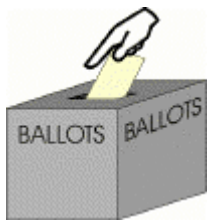

### Meet the Candidates

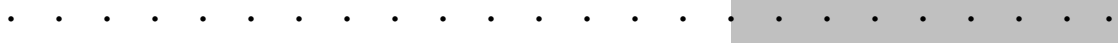
